ENUGU STATE OF NIGERIA, CALL CIRCULAR FOR 2025 BUDGET PREPARATION AND SUBMISSION

- 1.1. The Ministry of Budget and Planning, Enugu State hereby requests for your recurrent and capital expenditure proposals as well as the projected revenue for 2025 Fiscal Year.
- **1.2.** Ministries, Departments and Agencies (MDAs), should apply the Accounting Codes and Chart of Accounts in the preparation of the 2025 Budget.

2.0 2025 budget – General Guidelines

In preparing the budget proposals, Ministry/Department/Agency should strictly observe the following general guidelines:

The budget ceilings for both capital and recurrent provided in this call circular MUST be strictly adhered to. The budget ceilings are the maximum amounts that would be available to each MDAs in Year 2025 based on the MTEF (Medium Term Expenditure Framework) and therefore should not be exceeded. These ceilings were reached after a careful observation of the budget performances in the State for the past years and the prevailing National macro-economic indices.

- The policies, targets and strategies being pursued by your organization as contained in Manifesto of the present administration should be in consonance with your budget proposals. This means that your budget proposals should be in such a manner as to effectively translate into the attainment of your objectives / goals in line with the Development Agenda
- 4.1 Revenue projections for 2025 must be realistic and all embracing. The revenue projections should include indicative estimates for 2026 and 2027 while you are required not to not lose sight of the past trends especially past two years of 2022 and 2023 for details of revenue as designed in annexure 1 pg6
 - Hon. Commissioners/Chief Executive Officers and Permanent Secretaries/Accounting Officers have the primary responsibilities to ensure that estimates are in accordance with budget ceilings. Adherence to the budget guidelines and formats (see page 5) and the timely submission of budgets / estimates to the Office of the Hon. Commissioner, Ministry of Budget and Planning, Block B, State Secretariat, Enugu State will be highly appreciated.
 - All MDAs should be guided by the existing Rules and Regulations of the Civil Service and any other State or Federal Government Circulars as adopted by Enugu State Government for her Personnel Costs preparation.
 - You are required to provide all necessary information and update required in the capital expenditure in annexure VI
 - All MDAs involved in Food and Nutrition programme must ensure the Nutrition activities are clearly captured/tagged in the 2025 budget
 - Ensure to adhere strictly to the formats/templates in the annexures
 - You are reminded that your revenue and expenditure return for January to August 2024 should accompany your submission. (annexure V & VII)

3.0 The 2025 Budget Thrust or Focus

The 2025 budget focuses on achievement of the Development Agenda of this Administration on the following:

- Agriculture and Agro-allied Industrialization
- Energy and Mineral Resources Development
- Education and Human capital Development
- Commerce and Industry Development
- Creative Industry Development
- ICT Industry Development
- Urban and Rural Infrastructure
- Tourism Industry Development
- Water Resources Development
- Sustainable Prosperity

4.0 Revenue

All revenue generating MDAs are advised to make very realistic revenue projections based on all exploitable revenue potentials for the 2025 Fiscal Year. All revenue projections for the 2025 Fiscal Year should be submitted on Form MBP/2025/Rev/1 (Annexure 1). MDAs should refer to Approved Budget 2024

4.2 Actual Revenue:

Actual revenue for 2022, 2023 and collections made up to 30th day of August, 2024 should be shown in the appropriate columns in Form MBP/2025/REV/1 (Annexure I). This should also be used to capture the indicative revenue projections for the years 2026 and 2027.

5.0 Expenditure Projections

5.1 Budget Ceilings

It is important to note that the budget ceilings were arrived at after a realistic projection of the State Revenue in Year 2025. The ceiling should be seen as the limit to which resources could be stretched in the formulation of expenditure proposals for MDAs.

5.2 List of MDAs and resource envelopes (Ceilings) – Recurrent and Capital. The of MDAs and their respective recurrent allocations are shown in annexure VIII and capital allocations in annexure IX.

6.0 Personnel Costs:

- Generally, Personnel Costs should show the total salaries and allowances for all bona fide civil servants in each MDA. In order to have realistic personnel costs, the chief executive of the MDA is required to ensure that every post being provided for is truly an established post as defined above. You are also reminded that no Ministry/Department/Agency should provide for more than eight (8) departments, each to be headed by a Director in a fiscal year.
- The computation of staff personnel costs (salaries and allowances) should be based on the salary chart (supplied by the State Accountant-General) and in accordance with Forms MBP/E2025/NR/1 (Annexure II), MBP/2025/PC/GEN.89 (Annexure III) and MBP/E2025/ES/2 (Annexure IV); These clearly show the strength of the authorized established posts with their corresponding annual basic salaries for the years 2024 and 2025.

6.3 **Other instructions**

In compiling the Personnel Costs, the following should be noted and observed:

- The most current nominal roll should be used to project personnel Costs:
- In order not to distort the size of the service, MDAs with political appointees other than those allowed by the Constitution are advised to submit a separate Nominal Roll (Annexure II) for such political appointees marking such submissions as Annexure IIA:
- No abbreviations will be allowed for any established post. Every post must be written in full and clearly;

- Nominal Rolls must reflect financial provisions made for Officers only in the MDAs where they are paid, i.e. their pay points. Officers serving in non-scheduled establishments will be provided for in their parent Ministry/Department/Agency;
- Allowances other than the ones shown in Annexure II and which are currently enjoyed are to be shown on "Other Allowances Column" (Col.16). Authority backing such allowance is to be attached to the Organization's proposal;
- Care should be taken in computing the Personnel Costs as the Ministry of Budget
 and Planning will not undertake to make corrections on wrong submissions made.
 The practice whereby MDAs ask for corrigenda after the approved estimates have
 been published based on their wrong submissions will not be entertained. Vacancies
 will be entertained within the limit of the State resources and positions where
 necessary.

6.4 **OVERHEAD COSTS:**

The budget ceilings for overhead costs are provided in absolute monetary terms. It should be noted that improved service delivery is one of the cornerstones of the 8-point agenda and this would best be achieved when conscious effort is made to channel more of the limited resources towards those areas that would positively impact more on the quality of service provided. Therefore, while the total overhead costs proposal should not exceed the indicated ceilings, all MDAs are enjoined to prioritize and devote more resources to those areas that will enhance the delivery of their services to the citizens and in pursuit of the agenda of the State Government. Overhead cost submissions should be done in line with attached format. Annexure V,

The templates (schedules) in Annexure V should be used to estimate and capture the following overhead items: telephone, electricity, fuel and lubricants for vehicles, fuel and lubricants, generators, rent etc.

7.0 PROGRESS REPORT FOR CAPITAL EXPENDITURE

Up to date and detailed Progress Report (January – September, 2024) <u>must</u> be provided in accordance with the template provided in Annexure VI

8.0 2025 CAPITAL ESTIMATES

- 8.1 Top priorities should be given to completion of all <u>on-going projects</u> before the consideration of new ones
- 8.2 Capital Expenditure projections should be done in accordance with the approved budget ceilings for each MDA.
- 8.3 Capital Expenditure must reflect the 8-Point Agenda and general functions of Government and the Medium-Term Sector Plan. Thus, priority should be placed on those projects that will impact positively on the welfare of the citizens
- 8.4 Provisions should be fully made for the recurrent cost implications of the capital expenditure to ensure sustainability.

- 8.5 At all times due process must be followed in the procurement of goods and services and award of contracts.
- 8.6 MDAs should adequately prioritize new projects and select only those their Budget ceiling can fund adequately.
- 8.7 MEDUIM TERM EXPENDITURE FRAMEWORK: MDAs should also make their capital projections on the basis of a three-year Medium-Term Expenditure Framework (MTEF) that presents a detailed and realistic budget for the 2025 fiscal year and indicative forward estimates for 2026 and 2027 years (See Annexure VI: GHE/ESEPC/CAP/2025/002).

8.0 Parastatals and Tertiary Institutions:

The guidelines on the preparation of Revenue, Nominal Rolls, Personnel and Overhead Costs are also applicable to all Parastatals and Tertiary Institutions.

9.0 Formats and Templates:

- 9.1 MDAs are hereby requested to submit their revenue and expenditure proposals for the 2025 budget and strictly adhering to the attached formats and templates covering the various categories of revenue and expenditure. MDAs are strongly enjoined to carefully study the formats and templates and exercise due diligence in providing all necessary information.
- 9.2 In line with the general guidelines and formats/templates provided, MDAs are required to submit soft copies (two USB Flash Drive: recurrent and capital) and hard copies (Fifteen sets) each (Recurrent and Capital) of the duly completed 2025 Budget Proposals.

10.0 SUBMISSIONS AND BILATERAL DISCUSSION

- 10.1 Submissions of budget proposals must be made to the Office of the Hon. Commissioner, Ministry of Budget and Planning, State Secretariat, Enugu on or before Friday, 7th October, 2024
- 10.2 The attached timetable for the 2025 budget bilateral discussion will be adhered to.
- 10.3 Budget proposals that are not in accordance with the above guidelines will be rejected.
- 10.4 Hon. Commissioners / Head of Non-Ministerial Agencies and Permanent Secretaries are to sign the attached attestation form (Annexure X) and also lead their MDAs to the Budget Bilateral Discussion to ensure synergy, collaboration.
