Thus, this Budget Performance Report is a quarterly presentation that indicates the level of implementation of the annual budget of Enugu State Government within the year. The FY 2022 Q2 Budget Implementation Report of Enugu State Government exhibits the followings: FY 2022 Q2 performance; 2022 Performance Year to Date; Percentage Performance Year to Date against 2022 Budget; and Balance (against Budget).

The 2022 Appropriation was titled “Budget of Sustained Growth and Consolidation” bearing in mind the need to sustain the growth recorded in Enugu State in previous years under the leadership of His Excellency, Rt. Hon. Ifeanyi Ugwuanyi, Governor of Enugu State.

It is therefore, my delight to offer to you the 2022 Second Quarter (Q2) budget performance report of Enugu State which presents how far the State Government has gone in the implementation of the budget through the execution of people oriented projects and programmes in Enugu State despite lean resources.

I appreciate the Governor of Enugu State, Rt. Hon. Ifeanyi Lawrence Ugwuanyi for his commitment to deepen openness in governance and access to financial information as regards to Enugu State treasury. 1 Summary of Performance

1.A Introduction

This Budget Performance Report for Enugu State is prepared quarterly, and issued within four (4) weeks from the end of each quarter.

The 2022 Approved Budget, titled “Sustained Growth and Consolidation” was designed to sustain the growth and development recorded in Year 2021 in the State given the recovery of the economy from the negative consequences of COVID-19 pandemic. The 2022 budget focus revolves around diversification of State’s sources of revenue generation and provision of infrastructural facilities in healthcare, education, security, road network, environment, agriculture, water, electricity, as well as investments in youth empowerment, IT innovations, human capacity, rural development and good governance amongst others. Also within the year, the completion of all on-going projects are prioritized as this is the last twelve months’ budget this administration will fully implement.

The 2022 budget objectives and targets include:

1. Growing the proportion of IGR in the 2022 total resource envelope by 35%.
2. Upholding Budget Performance at not less than 85%.
3. Maintaining a capital expenditure to recurrent expenditure ratio of 60:40.
4. 100% cash backing of all expenditure approvals.
5. Strong Procurement Process and Certification.
6. Prioritising sectoral budgetary allocation and spending, in line with international benchmarks.

The sum of N186,635,135,582.00 (One Hundred and Eighty-Six Billion, Six Hundred and Thirty-Five Million, One Hundred and Thirty-Five Thousand, Five Hundred and Eighty Two Naira) only was presented by the Governor and approved by the Enugu State House of Assembly for 2022 fiscal year. Out of the approved budget size, the sum of N71,477,449,812.00 (Seventy-One Billion, Four Hundred and Seventy-Seven Million, Four Hundred and Forty-Nine Thousand, Eight Hundred and Twelve Naira) only, representing 38% of the approved budget is for Recurrent Expenditure while the sum of N115,157,685,770.00 (One Hundred and Fifteen Billion, One Hundred and Fifty-Seven Million, Six Hundred and Eighty-Five Thousand, Seven Hundred and Seventy Naira) only, is for Capital Expenditure, representing 62% of the approved budget size.

The 2022 approved budget has an opening balance of N15,000,000,000.00 (Fifteen Billion Naira), representing 12.83% of the approved Recurrent Revenue while other sources of Enugu State Government revenue makes up the approved recurrent revenue of N116,919,129,000.00 (One Hundred and Sixteen Billion, Nine Hundred and Nineteen Million, One Hundred and Twenty Nine Thousand Naira) only, composed as follows: N44,300,587,000.00 (Forty Four Billion, Three Million, Five Hundred and Eighty Seven Thousand Naira) representing 37.89%, N20,638,542,000.00 (Twenty Billion, Six Hundred and Thirty Eight Million, Five Hundred and Forty Two Thousand Naira) representing 17.65%, N34,000,000,000.00 (Thirty Four Billion Naira) representing 29.08%, and N2,980,000,000.00 (Two Billion, Nine Hundred and Eighty Million Naira) representing 2.55% of the total Recurrent Revenue are expected from the Federation Account Allocation Committee (FAAC),

Value added Tax (VAT), Internally Generated Revenue, and Excess Crude/Other Revenue sources, respectively.

On capital receipt, N12,557,000,000.00 (Twelve Billion, Five Hundred and Fifty Seven Million Naira) is expected from internal and external aids/grants while budget bridge financing (domestic and external borrowings) amounts to N47,246,966,582.00 (Forty Seven Billion, Two Hundred and Forty Six Million, Nine Hundred and Sixty Six Thousand, Five Hundred and Eighty Two Naira) and N9,412,040,000.00 (Nine Billion, Four Hundred and Twelve Million, Forty Thousand Naira) respectively. Expected receipts from Public Private Partnership amounts to N500,000,000.00 (Five Hundred Million Naira) while the sum of N45,441,679,188.00 (Forty Five Billion, Four Hundred and Forty One Million, Six Hundred and Seventy Nine Thousand, One Hundred and Eighty Eight Naira) transferred from Consolidated Revenue Fund (CRF) to the Capital Development Fund (CDF) makes up the total capital expenditure of N115,157,685,770.00 (One Hundred and Fifteen Billion, One Hundred and Fifty-Seven Million, Six Hundred and Eighty-Five Thousand, Seven Hundred and Seventy Naira).

In this report, the core economic classifications for expenditure are:

- Personnel – Economic Sub-Account Type 21
- Overheads - Economic Account Class 2202
- Capital - Economic Sub-Account Type 23
- Others - Economic Account Classes 2203-2209 as applicable

1.B Revenue Performance

In the 2nd Quarter (April - June), 2022 the total sum of N22,739,642,247.58 (Twenty Two Billion, Seven Hundred and Thirty Nine Million, Six Hundred and Forty Two Thousand, Two Hundred and Forty Seven Naira, Fifty Eight Kobo) was received as inflows from Recurrent Revenue. A total of N16,364,674,249.40 (Sixteen Billion, Three Hundred and Sixty Four Million, Six Hundred and Seventy Four Thousand, Two Hundred and Forty Nine Naira, Forty Kobo) was received as FAAC and VAT while the sum of N6,374,967,998.18 (Six Billion, Three Hundred and Seventy Four Million, Nine Hundred and Sixty Seven Thousand, Nine Hundred and Ninety Eight Naira, Eighteen Kobo) was realized as independent revenue (IGR).

Under Capital Receipts, the sum of N2,028,721,770.56 (Two Billion, Twenty Eight Million, Seven Hundred and Twenty One Thousand, Seven Hundred and Seventy Naira, Fifty Six Kobo) was received. However, it is expected that inflows from capital receipts will improve in the second half of the year.

1.C Recurrent Expenditure Performance

The second quarter of 2022 witnessed an aggregate recurrent expenditure of N18,205,892,240.61 (Eighteen Billion, Two Hundred and Five Million, Eight Hundred and Ninety Two Thousand, Two Hundred and Forty Naira, Sixty One Kobo). This is broken down as follows:

Personnel Cost: Personnel cost amounted to the sum of N11,915,058,408.56 (Eleven Billion, Nine Hundred and Fifteen Million, Fifty Eight Thousand, Four Hundred and Eight Naira, Fifty Six Kobo).

Overhead Cost: Overhead cost amounted to the sum of N4,819,941,354.49 (Four Billion, Eight Hundred and Nineteen Million, Nine Hundred and Forty One Thousand, Three Hundred and Fifty Four Naira, Forty Nine Kobo).

Other Recurrent (2203-2208): Other recurrent expenditure (General Public Service or Debt Services) stood at the sum of N1,470,892,477.56 (One Billion, Four Hundred and Seventy Million, Eight Hundred and Ninety Two Thousand, Four Hundred and Seventy Seven Naira, Fifty Six Kobo).

1.D Capital Expenditure Performance

During the quarter under review, the sum of N6,645,549,960.65 (Six Billion, Six Hundred and Forty Five Million, Five Hundred and Forty Nine Thousand, Nine Hundred and Sixty Naira, Sixty Five Kobo) was utilized for capital projects.

NOTE: As at the time of this report some revenues received and expenditures paid for have not been recorded for and as such will be captured in the subsequent budget performance reports within the year.

1.E Conclusion

Regardless of the limited resources facing the Nigerian economy and sub-nationals, Enugu State Government is striving to meet its promises to fund budget execution. Thus, the percentage performance year to date against 2022 budget indicates that recurrent revenue and capital receipts stood at 38.3% and 21.6% respectively while total revenue (including opening balance) stood at 35.8%. On the other hand, recurrent and capital expenditure performances stood at 32.4% and 12.9% respectively, while total expenditure stood at 20.4%. However, the performances thus far are promising better prospects for revenue and expenditure in the remaining quarters of the year whereas Enugu State government remain committed to openness, transparency and accountability in budget implementation, evaluation and feedback.
